

JANUARY 2005

NEW LAWS TOOK EFFECT January 1, 2005 THAT AFFECT Manufactured Homes

SB 1090 includes a requirement that mobile home dealers or salespersons disclose the effect of a net listing agreement, the amount of a buyer's offer, and the dealer's sales commission, to their client sellers, among other specifics.

AB 2351 requires the timely return of a signed copy of the rental agreement to the homeowner – within 15 business days after the homeowner has returned a signed copy to management. Another provision in this new law pertains to towing from a resident's driveway. There are also other specifics.



- 9. Check your security on a regular basis. When you change your clocks for daylight-savings time, check your computer security.

Good Use for Vinegar

Corrosion may be removed from shower-heads or faucets by soaking them in diluted distilled vinegar overnight. This is easily accomplished by putting a hose-end showerhead into a tall container filled with vinegar, or use a zip-close plastic bag filled with vinegar fastened to the fixture; or by saturating a towel in vinegar and wrapping it around the showerhead or faucet.




BBB ADVISES: Don't Ignore Bogus Billing During Holiday Rush

through the Refrigerator Replacement and Lighting Program of SDG&E may be available to you. This program provides energy-saving home improvement measures at no-cost to qualifying, limited-income households. In addition to a new energy-efficient refrigerator, measures may include the following fluorescent lighting accessories:

Compact light bulbs ~ Torchiere floor lamps Ceiling light fixtures ~ Porch light fixtures

Who is eligible: Eligibility is limited to SDG&E customers who meet specific household income guidelines and are NOT currently participating in, or eligible for, SDG&E's CARE or Energy Team programs.

To learn if you are eligible, call 858-514-4044. If you qualify, an Energy specialist will come to your home to determine the age of your refrigerator and install the energy-efficient lighting you select that meets the program guidelines. If your refrigerator is 14 years or older, a new refrigerator will be delivered and your old refrigerator removed.

STATE SAYS LOT MUST PROVIDE PROPER DRAINAGE

Moisture can damage your home and your health

A common complaint heard when it rains is about the smell odor of mildew afterward, or perhaps you have found mildew in your home several days of rain. Usually this is caused by accumulated water under your home because of poor drainage. This can cause moisture damage to the home, and sometimes, a serious allergic reaction to the mold which is a medical concern.

If you have had this situation before, or if you have it now after a rain, it would be best for you to notify the park management and that you are concerned about damage that could occur. You could give the park management a copy of subsections from the California Health and Safety Code, Section 1610, printed here, to indicate the need for management's involvement.

Mobilehome Lot Drainage Requirements

California Health and Safety Code, Section 1610, which is part of the Mobilehome Parks Act, is quoted, in part, as follows:

- "(a) The park area shall be so graded that there will be no depressions in which surface water will accumulate. The ground shall be sloped to provide drainage run-off by means of the surface or subsurface drainage facility.
- (b) The area beneath a mobilehome shall be sloped to provide for drainage beneath the mobilehome to an outside surface drainage facility.
- (c) Each mobilehome lot or site shall be grade to ensure that water cannot accumulate beneath the mobilehome."

Rights Reminder

Owners, Landlords or Managers may, within one hour after they notify, by telephone or, if impractical, by the most expeditious means available, the local traffic law enforcement agency, have a vehicle, which is located on the rental property, towed to the nearest public garage, as long as at least one of the following conditions exist:

- ~ there is displayed, in plain view, at all entrances to the property, a sign not less than 17 by 22 inches in size, with lettering not less than one inch in height, prohibiting public parking and indicating that vehicles will be removed at the owner's expense, and containing the telephone number of the local traffic law enforcement agency. The sign may also indicate that a citation may also be issued for the violation; or
- ~ a notice of parking violation has been placed on the vehicle and 96 hours have elapsed since the issuance of that notice; *or*
- ~ the vehicle is on private property and lacks an engine, transmission, wheels, tires, doors, windshield, or any other major part of equipment necessary to operate safely on the highways, and the owner or person in lawful possession of the private property has notified the local traffic law enforcement agency, and 24 hours have elapsed since that notification.

- ~ Consult your doctor or medical equipment supplier regarding battery-operated or other emergency back-up, as well as any special assistance that may be needed.
- ~ Have a blackout preparedness kit handy that includes a flashlight and extra batteries, a battery-operated radio and a phone that works without electricity (most cordless phones will not work without electricity).

Poinsettias

If you have a new Poinsettia, here are some tips to keep it healthy. Check the bracts for yellow pollen stains. If the plant has already shed its pollen it will soon begin to decline. When they aren't on display, keep plants in an area with bright light and high humidity. Proper care of your plant will keep it looking good through the season. Keep the plant in a brightly-lit room, but away from direct sunlight. It will do best in a temperature of 60F or below. Water your poinsettia only when the soil is dry down to an inch below the surface ~ about the depth of your finger up to the first knuckle.

Storing Leftovers To Avoid Bacteria

Careful attention to storing and heating holiday leftovers is important to reduce the risk of food poisoning, U.S researchers advise. William Stallings, a clinical dietitian at Temple University Hospital in Philadelphia, urges people to follow the "2-2-4" formula for safely storing foods. Two hours: Store all leftovers in the refrigerator or freezer no longer than two hours after cooking. Two inches: Use shallow containers, about two inches deep, to store food because it allows food to cool quickly. Four days: Eat leftovers within four days.

Coffee Talk

Keeping your morning coffee fix to one small cup may be better for your health. In a recent study, people who consumed excess coffee each morning tended to have higher blood levels of certain inflammatory proteins, compared to people who drank less coffee or who were non-coffee drinkers. Anything over a small cup (about 6.5 ounces) per day was associated with the increase in inflammatory markers.

Bill-paying Tips

Here is what financial experts say you should consider before signing up for automatic payments:

- Check out the company before giving it access to your account information and make sure it is easy to reach if something goes wrong.
- Keep careful track of expenses to avoid overdraft fees and expensive line-of-credit charges.
- Check statements for errors and report any to the bank immediately. By law, a bank must investigate any dispute. If it cannot figure out within 10 days who is in the wrong, it must restore the money until the dispute is resolved.
- Adjust bill-payment dates if your payday changes or if you change jobs, so that there is always enough money in your account to cover withdrawals.
- Ask for a "switch kit" if you change banks. Often, banks will handle the paperwork to switch automatic payments to your new account. San Diego Union-Tribune ~ Dec. 6, 2004 (New York Times News Service)






